AFFIDAVIT OF EXEMPTION

If the property owner does hire a contractor to perform any work pursuant to the building permit, said contractor must provide proof of Worker's Compensation Insurance to the Borough of Economy. The homeowner assumes any/all liability for the contractor's compliance with these requirements.

\_\_\_\_\_ The Contractor has no employees. The contractor is prohibited by law from employing any individual to perform work pursuant to this building permit unless the contractor provides proof of insurance to the Borough of Economy.

\_\_\_\_\_ Religious exemption under the Worker's Compensation Law. All employees of the contractor are exempt from Worker's Compensation Insurance.
